SUMMARY/HIGHLIGHT:

At the June meeting of the Spring Hill CRA, the Board asked to update the Exterior Grant Program policy to include language that requires a statement from the contractor/vendor that the improvement is needed. The Board also asked to include language seeking information on whether the applicant has applied/received any other grant funding for the same project.

Staff has inserted the updated language into the policy and application and that is attached for review and approval.

RECOMMENDATION:

It is recommended that the updated Exterior Improvement Grant policy and application be approved.

BACKGROUND/DISCUSSION:

The last time the Exterior Improvement Grant was updated was in 2024. During that update, the Board approved an increase in the CRA match percentage and approved the simplification of the match tiering from two to one tier. This item was continued from the September 2025 meeting.

SPRING HILL

EXTERIOR IMPROVEMENT PROGRAM

The City of DeLand and the County of Volusia, through its visioning process, has identified the revitalization of the Spring Hill as one of the elements in creating a strong vibrant community. A series of initiatives have been instituted to assist in the revitalization efforts. The Community Redevelopment Agency has created an Exterior Improvement Grant program that is designed to assist businesses and homeowners in refurbishing their properties. This matching grant program is available to commercial properties and homeowners within the Spring Hill tax increment district for refurbishing building facades and improving exterior yards or parking areas. Eligible projects may receive Grant Awards of:

- 75% of the costs for projects totaling \$5,000.00 which is reimbursable to the owner/applicant upon approval of the completed project by the Spring Hill Neighborhood Association's grant review committee.
- Maximum grant award cannot exceed \$5,000.
- Business or homeowners who are unable to finance their projects may have funds paid directly to a contractor in order to facilitate the project completion.
- The following projects **cannot** be used as a part this grant: roof replacement or patching.
- Applicants that have received or are actively applying for additional grants/awards for the requested project may be rejected.
- The following projects **can** be used as a part of this grant: replacement windows, replacement exterior doors, fencing, grass, shrubbery replacement, painting and the cleaning of yards or parking areas.
- **Two estimates are required for each project.** The contractor needs to verify that the improvements are needed.

The grant program will be administered by the Community Redevelopment Agency (CRA), The City of DeLand and the Spring Hill Neighborhood Association (SHNA). The SHNA staff will assist applicants through the grant process; however it is the applicant's responsibility to meet the requirements of the grant program and all applicable City/County regulations. “B” GRANT PERMIT REQUIREMENTS

Certain areas of Spring Hill are located within the City of DeLand’s municipal limits. The DeLand Building Department, located at City Hall, 120 S. Florida Avenue (phone: 626-7007) issues permits for properties within the City limits. For areas outside of the City limits, the Volusia County Permit Center issues building permits. Their office is located in the Thomas C. Kelly Administration Center, 123 W. Indiana Avenue (phone: 736-5928).

Owner may act as their own contractor; however, permits must be obtained when required.

PERMITS MAY BE REQUIRED FOR THE FOLOWING ITEMS:

- Electrical
- Awnings
- Signage
- Renovation – Structural Renovation or Structural Aesthetic Changes
- Tree removal
- Window replacement

No permits are needed for painting or spray cleaning.

Owners or grantees are responsible for meeting with City or County building officials prior to grant application to find out the legal needs, permits, etc. Owner/grantee must comply with all relevant requirements. Owner/grantee is responsible for making certain that their contractors have pulled the proper permits.

“C” GRANT AWARD CRITERIA

1. Installation or replacement of broken or missing doors, windows and screens.
2. Exterior building repairs of sagging porches; broken steps and railings; support column repair; exterior wall repair; repair of gutters and/or downspouts; etc.
3. Repainting of buildings with peeling paint.
4. Installation or rehabilitation of signs and canopies.
5. Removal of dead trees and landscaping, and junk and debris from yard areas.
6. Installation of water-wise landscaping materials
7. Non-repeat location within five years.
8. Contractor/Vendor needs to verify the improvement is needed.

AGREEMENT

I understand that in order for my request for funding to be approved, I must agree to follow the recommendations of the SHNA Grant Committee and comply with the following:

1. Exterior Improvement grants apply only to those buildings and properties within the Tax Increment District.
2. Only projects which have not received grant funds within the past FIVE (5) years will be given consideration.
3. It is the responsibility of the owner or APPLICANT to obtain all required permits from the city or County **BEFORE** beginning any work. No reimbursements will be received without the proper permits before work begins.
4. Project work must begin 30 days after permits are obtained.
5. Monies are for exterior improvements only and will be reimbursed upon completion of work. (Any changes made to the property that have not been approved by the SHNA Grant Committee will not be funded.)
6. For projects where the applicant is not the property owner, the applicant must obtain approval in writing that the property owner concurs with the execution of the proposed work.

NOTE: NO PROJECT WORK MAY BEGIN WITHOUT:

1. CRA Approval.
2. Signed Contract Documents (including statement that improvement is needed)
3. All required permits. (See Exhibit B)

“E” EXTERIOR IMPROVEMENT GRANT CONTRACT

This agreement is made and entered into the ____ day of _____, _____ by and between the SHNA DeLand Association, (hereinafter “Association”) and _____ (hereinafter “Contractor”) and _____ (hereinafter “Applicant”), for a grant project on the property located at _____, for and in consideration of the mutual covenants expressed herein and other good and valuable considerations. The adequacy of which is hereby acknowledged, the parties agree as follows:

CONTRACTOR AGREES

- A. To perform the work for the project set forth in the specifications attached hereto and made a part hereof in a workmanlike manner and all work shall be done in strict conformance with all applicable federal, state, county and city codes, laws, regulations and ordinances.
- B. To commence the specified work within 30 days after the approval of the project by the SHNA Grant Committee and the Spring Hill Community Redevelopment Agency and obtaining all required permits and to complete the work within ____ days after commencement, including such extensions as may be granted by the SHNA Grant Committee and applicant in writing.
- C. To guarantee all work performed by him/her for a period of one year against defects in workmanship and materials.
- D. To hold harmless the SHNA Grant Committee and its individual members, the “Association” including its Executive Director and employees and the City of DeLand or the County of Volusia in the event of property damage, personal or physical injury occurs as a result of working on the project.
- E. Unless prior arrangements have been made, The SHNA Grant Committee or the City of DeLand does not pay the Contractor, and the Contractor shall not bill the SHNA Grant Committee or the “Association” or the City. Reimbursement of \$_____ shall be made by the City of DeLand to the Applicant upon contractor’s completion of work, and the SHNA Grant Committee and City of DeLand’s on site inspection and acceptance of same. Contractor shall seek payment for their performance under the contract from the applicant.

“E” EXTERIOR IMPROVEMENY GRANT CONTRACT (continued)

THE “ASSOCIATION” AGREES:

The work in progress will be inspected by the Association and the Association will work with the Applicant and the Contractor to ensure that the work meets the objectives of the Exterior Improvement Grant Program. Neither the SHNA Grant Committee nor the “Association” will be responsible for the quality of material and workmanship.

THE “APPLICANT” AGREES:

1. To bear responsibilities to the Contractor for total cost of the project.
2. To maintain, with no substantial changes, the facade and improvements for ten (10) years unless otherwise agreed to by the SHNA Grant Committee and the CRA.
3. To submit to the guidelines of SHNA Grant Committee and the CRA for the project.
4. To hold harmless the SHNA Grant Committee and its individual members, the “Association” including its Executive Director and employees and the City of DeLand in the event of property damage, personal or physical injury that occurs as a result of the project.

SUMMARY/HIGHLIGHT:

During the FY 24/25 Budget process, the CRA asked staff to come up with some additional grant programs that could be utilized in Spring Hill that align with the Main Plan document. One of the items that received conceptual approval was a small business grant program. After doing research, staff created a small business grant program and policy.

This program is aimed to encourage small business expansion and relocation into the Spring Hill CRA to create jobs and further economic opportunity. The grant would help the business pay for expenses such as impact fees, connection fees, and certain infrastructure improvements that typically arise when building or expanding a property to accommodate a new business or growing business.

The grant proposed is a 50% match up to \$10,000 per grant award. The applicant has to meet several eligibility requirements. The total amount in the CRA budget allocated for this grant is \$50,000.

Staff is seeking feedback from the CRA on the grant policy and application language so that it can be ready to launch in the upcoming fiscal year.

STRATEGIC PLAN FOCUS AREA/ACTION STEP:

Effectively Provide Infrastructure and Services to Residents and Businesses, Attract Investment and Create Value through Public & Private Community Partnerships and Initiatives, & Provide Job Opportunities, Training and Skill Enhancement Opportunities for Residents.

FISCAL IMPACT:

\$50,000 has been allocated in the current and future CRA budget.

RECOMMENDATION:

Staff recommends that the CRA provide feedback and/or approve the policy and application as presented.

BACKGROUND/DISCUSSION:

One of the items that the CRA wanted to focus on with the reserve allocation funding was an increase to our current grant offerings. Currently, the Spring Hill CRA has an Exterior Improvement Grant and Sewer Connection Assistance Grant. The Small Business Assistance Grant would be an additional option that can be accessed by stakeholders. This item was continued from the September 2025 meeting.

SPRING HILL CRA

SMALL BUSINESS ASSISTANCE PROGRAM

The City of DeLand and the County of Volusia, through its visioning process, has identified the revitalization of the Spring Hill as one of the elements in creating a strong vibrant community. A series of initiatives have been instituted to assist in the revitalization efforts. The Community Redevelopment Agency has created a Small Business Assistance Grant program that is designed to encourage small businesses to locate, expand or redevelop in the Spring Hill CRA.

The grant provides matching funds to new and expanding businesses in the CRA to assist in off-setting development fees, including sewer connection fees, building permit fees, and public right-of-way infrastructure that may require new installation, repair, replacement or relocation.

Eligible improvement include:

- Street lighting, hydrant installation/relocation, sidewalk repairs, water and sewer construction, traffic safety improvements, curb, gutter, and street improvements.

The Spring Hill CRA staff and the City of DeLand Economic Development Division administers and monitors the program and determines eligibility of applicants.

The program requires eligible business owners to pay 50% of the fees/costs assessed and the program will fund the remaining 50% up to \$10,000 per award. Funding is on a first come first serve basis and resets each fiscal year with the annual budget approval of the Spring Hill CRA.

Eligibility Requirements:

- Business must be located/relocating within the Spring Hill CRA limits.
- Applicants must be a new, for-profit business or expanding existing for-profit business located within the Spring Hill CRA. The business must be a small business as defined by the Small Business Association.
- All applicants must obtain or possess a City of DeLand Tax Receipt if the business is located within the DeLand city limits. New business owners must obtain a BTR within 90 days of agreement execution and provide a copy the CRA staff.
- All applicants must be current with federal, state and local taxes.
- Applicants and property owners may reapply for the grant one year after the termination date of the existing program agreement.
- Applicants must obtain all necessary building permits and meet the appropriate building code.

- No award will be retroactive.
- All applicants/businesses must be in compliance with applicable city and county rules and regulations.

- Construction

- Transportation
- Retail
- Restaurant
- Personal Service
- Medical Service and Support
- Local Chain Small Businesses that are headquartered in Central Florida

- Health, medical and social services businesses to include but are not limited to walk-in clinics, pain management clinics, hospitals, chain pharmacies, detoxification centers/clinics, residential care facilities and labs.
- Agricultural services
- Not For Profit Organizations
- Tattoo and Body Piercing Establishments
- Adult Entertainment
- Adult oriented or adult themed businesses
- Nightclubs, bars, or taverns
- Liquor stores
- Gun shops
- Pawn shops
- Home-based businesses
- Businesses that sell drug paraphernalia

- Any business with outstanding code enforcement violations
- Any business that is not current with federal, state, and local taxes

SUMMARY/HIGHLIGHT:

One of the work plan items that the Board requested staff to review relates to the future use of 910 South Adelle Avenue. This location was the former location of the Dr. Joyce M. Cusack Resource Center. The land is owned by the City of DeLand and has been the operational base of the Dr. Joyce M. Cusack Resource center for many years.

The lot is a small lot that is roughly 1/4 of an acre. It is located within the CORE area of Spring Hill. Redevelopment of the CORE area is referenced as a specific focal point of the master plan for the CRA.

Earlier this year, a class from the Public Administration school at Stetson University performed a class project on what potential future uses could go on this site. The students collected responses online and in person by attending local events in Spring Hill and seeking input from clients that have come to the Dr. Joyce M. Cusack Resource Center. A total of 168 respondents provided feedback. 122 of the 168 of the respondents stated that they were residents of the Spring Hill area.

Additionally, the students then held a public workshop with the community where the students presented their ideas and collected community feedback on those ideas.

At the conclusion of the survey, the following options were listed as the most popular responses:

- Parking for Macedonia Baptist Church/Event Parking
- Community Garden
- Passive Park/Playground
- Community Center
- Market Space
- Housing Shelter/Housing Assistance
- Small Urgent Care Facility

Ms. Kieu Moses will be present tonight to provide additional details on the Stetson project, if the Board has any questions. Ms. Moses was the Professor for the Stetson University class.

Staff would like to note in speaking with our Community Development Department that the parcel is a small site but could be able to be redeveloped for a small commercial use or three-family use site (not withstanding the engineering, parking, stormwater, etc.. and economics of such a request).

Alternatively, another option the Board could choose is to put the property up for sale. At the time of the creation of this agenda item, the surrounding properties at 905 and 918 S. Adelle are currently listed on the market. 905 S. Adelle is listed at \$499,000 and 918 S. Adelle is listed at \$599,000. It is not currently listed, but 921 S. Adelle was also up for sale earlier this year but came off the market in March. The property appraiser lists the just value of 910 S. Adelle Ave. at \$23,000. If the will of the Board is to put the property up for sale, staff recommends that the property receive an appraisal prior, so that it is posted at the current market valuation.

- **Park/Playground:** Many residents wanted a space for children (and dogs) to play, with benches and green areas
- **Community Center or Resource Hub:** Suggestions included job support, legal aid, health services, and social services
- **Market Space:** Ideas included a small marketplace or micro-kiosks for local businesses to sell goods
- **Homeless Shelter / Housing Assistance:** Several people advocated for a shelter or a place to find affordable housing options

- **Sports Complex or Skate Park:** While some wanted recreational areas, larger facilities like a sports complex or skate park had little support compared to general parks
- **Parking Lot:** A few responses suggested a simple parking lot, but this was overshadowed by interest in active-use spaces
- **Event Venue:** The idea of a space for concerts or large events was mentioned but didn't gain much traction compared to more practical community services
- **Fitness Area:** A few people suggested workout equipment, but it didn't receive as much support as a general park or community center

OLDER RESPONDENTS

Respondents who were between the 45-64 age range focused on practical support for the community, like access to essential services. Unlike younger groups who preferred more active recreation, this group also leaned toward calm, useful, and inclusive spaces.

- Community Resource Center (Health Services, Job Help, Social Services, etc.)
- Senior & Family-Oriented Spaces (Community Garden, Quiet Park, Family Activities, etc.)

YOUNGER RESPONDENTS

This group prioritized spaces for physical activity, socializing, and outdoor fun. Some were also interested in career development, entrepreneurship, and skill-building opportunities.

- Recreational Spaces (Park, Basketball Court, Playground, etc.)
- Job Training & Small Business Support tailored center

FINAL SURVEY OBSERVATIONS

- Several of the nonresidents wished for whatever the locals wanted/needed
 - There was one respondent who was 17 and under
- Surveyors recognized that there were many that did not know where Springhill was
- Accessibility: 81 respondents said very important, 22 respondents said somewhat important, and 1 said not important
- Most residents are more prone towards a sense of community, hence the popular suggestions leaning toward Community Gardens or Community Centers

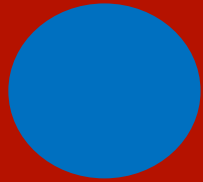

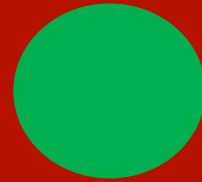

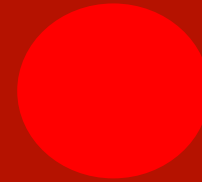

SMALL URGENT CARE

- Small urgent care received 29 votes.
- Small Urgent Care received the most "Loved it" votes (6), making it the most favored option.
- This could provide immediate, affordable medical attention for minor injuries, illnesses, and preventative care.
- This could reduce the community's reliance on ER visits.
- By bringing urgent care directly into the neighborhood, residents gain quicker access to essential services, improve overall health outcomes, and foster a stronger healthier community.



PASSIVE PARK

- Passive Park had a balanced range of feedback, leaning positive.
- Passive Park got 19 votes.
- Offers a safe, peaceful space where residents can walk, relax, and enjoy nature without having to leave their neighborhood.
- Green space is often limited in spaces like this.
- A park can promote mental health, community gathering, and a sense of pride in the area.



GARDEN

- Garden had 17 votes.
- Garden like Temporary Housing had mostly "Okay" and "Great" responses, with few strong positive reactions.
- A community garden could empower residents to grow their own fresh fruits and vegetables.
- This can create educational opportunities across generations, promote healthier eating habits, and all while making the neighborhood more beautiful.



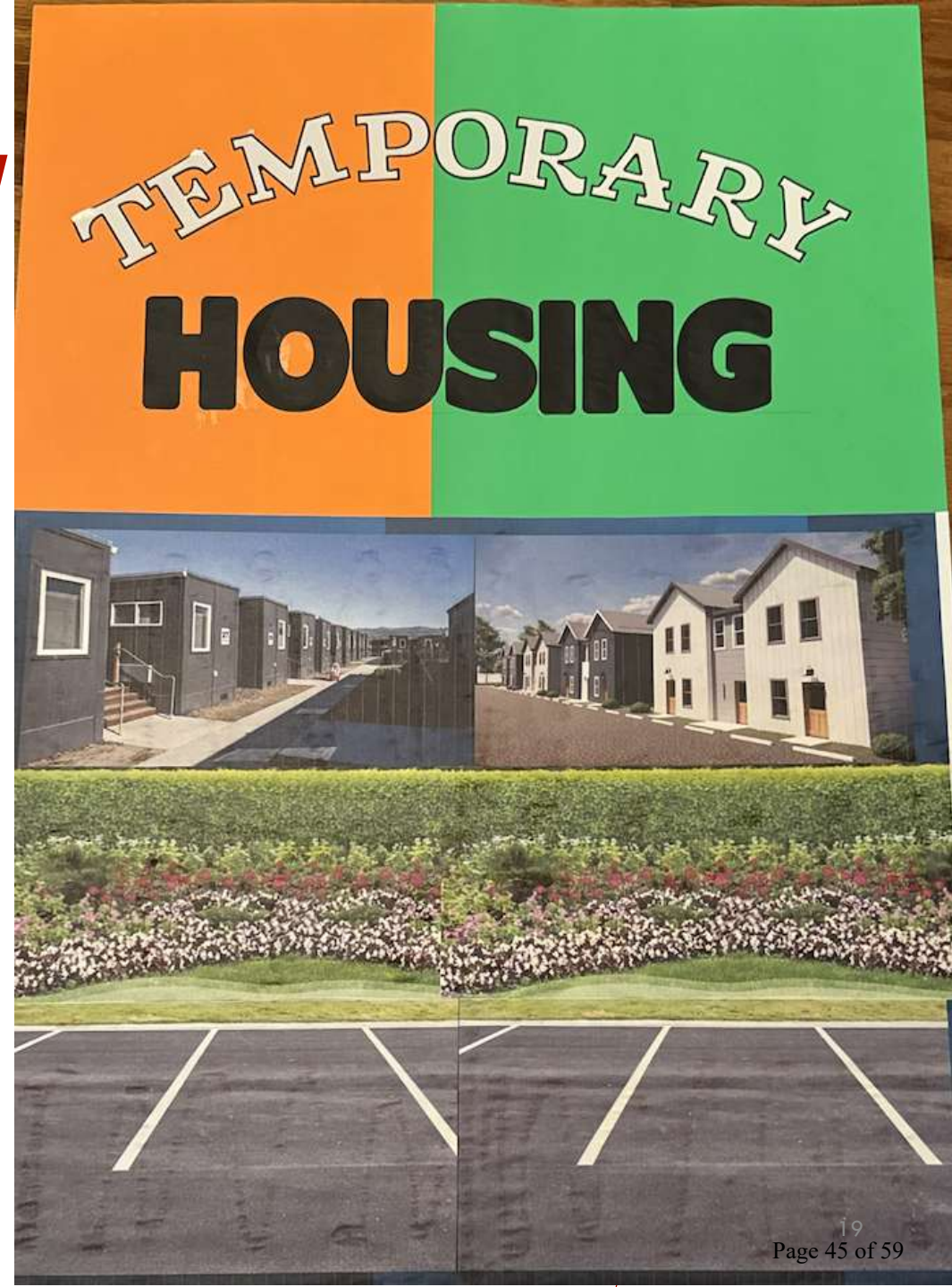
MARKET

- Market had the most "Liked it" votes (4), but overall mixed opinions.
- Market had 16 votes.
- A local market could provide easy access to fresh produce, household essentials, and local goods at an affordable price.
- Having basic needs that are easily accessible without having to drive are essential in places like this.
- This could create jobs and support local entrepreneurship and boost the local economy.



TEMPORARY HOUSING

- Temporary housing like garden had mostly "Okay" and "Great" responses, with few strong positive reactions.
- Temporary housing had 11 votes.
- This could offer stability and dignity to individuals and families facing homelessness or housing insecurity.
- Providing short-term shelters would help vulnerable residents regain their footing, access needed services, and work towards permanent housing solutions. This would strengthen the entire community.



DIRECT QUESTIONS FROM ATTENDEES

"Is the garden [proposed project idea] going to be where people can set up a space?"

"Are you aware there is already garden here somewhere—one not being used?"

"With the market idea... Would this be a flea market or a daily thing? Would this be a competitor to the market already here close by?"

Temporary Housing: "Would this be a project to tackle some of the homelessness in our community? There is a homeless mental health issue in the city, so you should try to combine a temporary housing building with a small business tied to it for mental health solutions."

CONCERNS FROM SPRING HILL RESIDENT ATTENDEES

- A few residents felt the general population's voices were not being represented and that the surveys were not reaching the broader Spring Hill community
- Multiple attendees expressed a strong preference for the lot to be used as additional parking for the nearby church
- They emphasized that many other Spring Hill residents, though not present, shared the desire of adding additional parking. The parking lot was seen as a way to support church members and community events



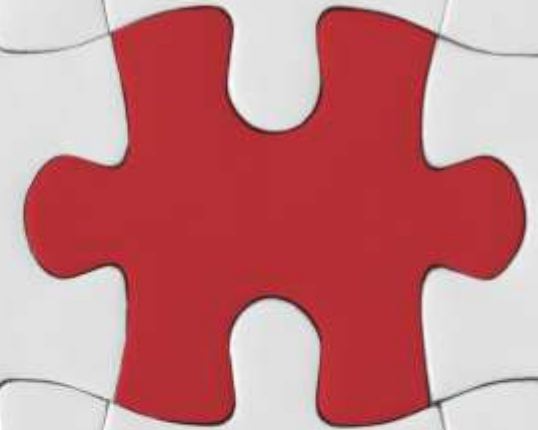
SUGGESTION BOX RESULTS
